## **RE: Board Appointments – Lack of Timely Nominations**

The Chairs of the Land and Water Boards of the Mackenzie Valley (the Boards) are writing in follow-up to our letter of August 21, 2020 to the Minister of Northern Affairs<sup>1</sup> and our subsequent meeting with the Minister on September 18, 2020. Minister Vandal acknowledged the importance of timely Board appointments and committed to putting more focus on the process as a whole. The Chairs wish to reiterate the appointment of Board members to the Land and Water Boards is a federal responsibility that is not limited to the signing of appointment letters but includes ensuring the nomination process is conducted in a timely manner.

The Boards currently have vacancies and are facing many more in the near-term. These are listed below per nominating party:

- 1) Government of Canada:
  - The term for Kimberly Fairman (MVLWB) expired on August 13, 2020.
  - The term for Violet Doolittle (SLWB) expired on August 22, 2020.
  - The term for Gerry Kisoun (GLWB) expires March 1, 2021.
  - The term for Rachel Crapeau (WLWB) expires May 23, 2021.
- 2) Dehcho First Nation:
  - The term for Sam Gargan (MVLWB) expires on November 29, 2020.
- 3) Akaitcho Territory Government:
  - The term for Florence Catholique (MVLWB) expires on March 1, 2021.
- 4) Gwich'in Tribal Council:

- The term for Nigit'stil Norbert (GLWB) expires March 1, 2021.
- 5) Government of the Northwest Territories:
  - Nominee for the WLWB submitted early March 2020.

Given that our recent experience with appointments indicates at least 9 to 10 months are required from the time of a nomination being submitted to the Minister and an appointment being approved, the Boards are currently anticipating significant vacancies in the coming months. The Boards are very busy, and these gaps create operational difficulties that impact the effectiveness and efficiency of our work.
