Dear Minister Vandal,

RE: Land Use Permit Extensions – Request for Amendment to Mackenzie Valley Land Use Regulations

The Land and Water Boards of the Mackenzie Valley, or the Boards (Gwich'in, Mackenzie Valley, Sahtu, and Wek'èezhìi Land and Water Boards), are writing to request that the *Mackenzie Valley Land Use Regulations* (MVLUR) be amended with respect to land use permit extensions to make them consistent with the federal *Territorial Land Use Regulations*.

The Boards' request stems from the recently abandoned judicial review that the NWT and Nunavut Chamber of Mines filed in May 2021 in response to the Boards' decision to limit extensions to land use permits to only once and for a maximum of two years. The judicial review, which concluded prior to having the opportunity for the court to clarify the interpretation question, put a significant financial burden on the Mackenzie Valley Land and Water Board, and as a consequence we would like to avoid the possibility of another such occurrence.

Sections 31(5) and (6) of the *Territorial Land Use Regulations*, which apply to permits for areas under the control, management and administration of the federal government in NWT and Nunavut, are explicit that a permit's duration may be extended only once. We recommend that similar clarity be brought to the MVLUR at your earliest convenience.
