- Transparency: We are committed to ensuring our processes and decisions are clear and accessible.
- Fairness: We consider all perspectives to develop impartial and evidence-based decisions.

- Excellence: We pursue professional and creative solutions, modelling our values at all times, through our role and work with others in the co-management system.

# **Meet the Chairs**



#### Mackenzie Valley Land and Water Board (MVLWB)

The Chair of the Mackenzie Valley Land and Water Board (MVLWB), *Mavis Cli-Michaud*, was appointed in March 2017 and has been serving on the Board since 2014.

She has more than 30 years of experience working for the federal government with a focus on communications, finance and human resource management, as well as socio-economic planning.



#### Sahtu Land and Water Board (SLWB)

The Chair of the Sahtu Land and Water Board (SLWB) is **Tanya MacIntosh**, a Sahtu Land Claim beneficiary. Joining the SLWB as a board member in 2019 Tanya was recently appointed Chair on June 1st, 2021. Her work experience includes Forest Fire Management and 17 years as a Geomatics Engineering Technologist. Tanya has also participated in multiple Career Day Fairs within the Sahtu Region and continues to encourage and support youth capacity building.



#### Gwich'in Land and Water Board (GLWB)

The Chair of the Gwich'in Land and Water Board (GLWB) is *Liz Wright*, from Fort McPherson, NT. She was first appointed as a member of the GLWB in July 2007 and appointed Chair in March 2018. Liz has worked for the Member of the Legislative Assembly for the Mackenzie Delta riding for the past 12 years and enjoys her job, mostly getting out to communities, meeting old friends and gaining new friends.

#### Wek'èezhii Land and Water Board (WLWB)

Born and raised in Behchokỳ, *Mason Mantla* is a Tłįchǫ citizen who is deeply connected to his community and culture. His educational experiences include graduating from Jimmy Bruneau Regional High School, courses at the University of Victoria's 2011 Summer Institute at the Centre for Aboriginal Health Research and being part of the pilot semester at Dechinta Centre for Research and Learning in 2010. Concerned by the problems and issues in his community and the health of the environment, Mason strives to make a positive difference in the lives of the Tłįchǫ people. Currently, Mason works as a freelance videographer and entrepreneur. In addition to his love of music (Mason has been writing songs since the age of 12 and playing guitar and singing since the age of 16), filmmaking, Mason loves spending time with his daughters Evie and Theia. Mason was nominated to the Wek'èezhii Land and Water Board by the Tłįchǫ Government on May 27, 2011 and has been on the Board ever since. On December 9, 2021, Mason was confirmed by the Minister as the new Chair of the Wek'èezhii Land and Water Board.

# OUTREACH

The Land and Water Boards of the Mackenzie Valley (LWBs) are committed to increasing our efforts on outreach and relationship building with parties, applicants, and the public to support collaboration and effective implementation of an integrated co-management system. Our primary goal is to focus on ways to connect with community members within the Mackenzie Valley to support participation in the regulatory process. Our aim is to contribute to ongoing, meaningful, and mutually beneficial relationships. We recognize that a thorough and thoughtful process has potential that can allow for reciprocal relationships for the LWBs of the Mackenzie Valley and the communities and its people of the NWT.

Strengthening local relationships between communities and LWBs enhances better decision making. To better understand and engage in this local relationship the LWBs provide cultural awareness and competency training to LWB staff to gain more knowledge about the customs and traditions of the Indigenous communities in their area. This provides a means for co-management bodies and communities to engage in dialogue to better understand each party's respective needs and expectations in relation to natural resources.

Initiating dialogue sessions with communities and the Board(s) can continue to build relationships and provide opportunities to discuss shared priorities. We invite all affected to come and share information on upcoming and current projects, and areas of concern.

Youth engagement through job fairs, school tradeshows, and school visits, including pre- and post-secondary is one way that the LWBs hope will encourage current and future participation in the co-management system in the Mackenzie Valley. Other avenues include visits and presentations with community members for an increased knowledge base of our regulatory process.

### Information and Communication Technologies New Online Review System (ORS)

The Land and Water Boards of the Mackenzie Valley and the Mackenzie Valley Environmental Impact Review Board (collectively the Boards) are excited about the launch of the new ORS in June of 2021. In addition to the wish list of improvements gathered over the years, more than 50 interviews with various stakeholders in the Mackenzie Valley took place to guide the development of the new ORS. New features include: the option to view all reviews at once and also view past reviews, enhanced security, the ability to submit audio recommendations, a map related to the submission under review, and more intuitive navigation throughout the site. The new ORS is built on open-source code that will allow updates to be made more easily moving forward, so the Boards welcome your feedback on the ORS. ## **CO-MANAGEMENT SYSTEM**

#### **The External Factors**

There are several aspects evolving in the external environment which may impact the LWBs over the next five years. The first is Reconciliation. Canada is in an era of Reconciliation with Indigenous Peoples, with significant changes taking place based on the recognition of rights, respect, cooperation, and partnership. This context will continue to evolve, shaping the landscape in which the LWBs operate. The second is Land Claims and Self-Government. The status of agreements, rights and governance continue to evolve in the NWT. As additional land claims are finalized this may also have implications for the structure and role of specifically the Mackenzie Valley Land and Water Board. Further, as Indigenous governments continue to grow capacity, there may be changes in how these governments expect

The third is Devolution Agreement Review. Although the Northwest Territories Land and Resources Devolution Agreement (Agreement) was finalized in 2013 (and accompanying legislation brought into force in 2014), some of these changes are only being realized now and these will need to be internalized and implemented. In addition, the Agreement is to undergo a review in the near term, which may create further changes to governance in the Northwest Territories. It will be important for the LWBs to have input into the review process, recognizing that the outcomes of the review may have implications for the LWBs. The fourth external factor is Legislative change and legal context. Legislative change and implementation will continue to have implications for Board and staff operations.

The following legislation/themes are potential areas that may impact Land and Water Boards in the next five years: Implementation of existing legislation. changes associated with the Public Land Act (which received Royal Assent in 2019); anticipated legislative change to the Waters Act and the Environmental Protection Act and emerging changes associated with Crown consultation, waste management and tailings management. There are also dynamic, global issues with local implications. Government and policy makers are being asked to respond to increasingly complex, uncertain, and dynamic challenges that are occurring globally, such as climate change and the Covid-19 pandemic. These challenges may require the Land and Waters





Boards to continue to be nimble and responsive in how we work and where we place our focus.

#### 2021 Mackenzie Valley Resource Management Act Resource Co-Management Workshop Report Released

On March 9-11, 2021, the LWBs of the Mackenzie Valley, the Mackenzie Valley Environmental Impact Review Board, the Government of the Northwest Territories, and the Government of Canada hosted the annual *Mackenzie Valley Resource Management Act* (MVRMA) Resource Comanagement Workshop. The 2021 workshop is the first time that we engaged and learned from each other in an virtual format. The theme was well-being and the MVRMA. Over the three-day workshop we heard about the importance of ongoing discussions, stronger relationships, and partnerships to contribute to lasting well-being by making good decisions with good information. Through this shared mutual learning experience, we heard from many speakers and participants whose knowledge sharing play a leading role in shaping dialogue that aids us in moving forward to develop best practices and approaches to understanding the well-being of the people we serve.

These workshops improve our understanding of interconnectedness with our natural environments, communities, and each other. We look forward to continuing our work and continuing to build strong partnerships to promote and protect well-being in the Mackenzie Valley.
